CONDITIONS AND REQUIREMENTS FOR RIGHT-OF-WAY CONSTRUCTION ACTIVITIES

- Call Underground Utility Locate Center 48-hours in advance of construction (1-800-424-5555).
- All work will be performed in accordance with current City Engineering Standards and this permit.
- In the event of any violations of the above conditions, Stop Work orders may be posted.
- **BONDS:** Bonds must be 150% of the Value of Work (minimum \$1,000.00). The applicant must submit an itemized cost estimate along with Cash Deposit or arranged Assignment of Funds with a local bank. Surety Company Bonds must be *SITE SPECIFIC*; general Company Bonds may not be used. Unless otherwise approved by the City Engineer, all Bonds will be retained for a minimum of two years.
- **INSURANCE:** Contractors shall supply the City a copy of their General Liability Insurance, naming the City of Snohomish as an additional insured, pursuant to WSDOT Standards and Specifications for Road, Bridge, and Municipal Construction Section 1-07.18.

I hereby attest and acknowledge that I have read the above conditions and requirements of this permit and have full understanding of the same. I agree to indemnify, hold harmless, and defend the City, its elected officials, officers, employees, agents, from and against any and all claims, lawsuits, damages, costs, charges, or other losses, whether to persons or property resulting from, arising out of, or related in any manner to the activities conducted under this permit.
